ActionCOACH Privacy Policy

ActionCOACH values and is committed to safeguarding your personal information. It is our desire through this Policy that you understand how your Personal Information will be handled when submitted through the ActionCOACH website.

ActionCOACH defines “Personal Information” as identifiable information such as your name, street address, telephone number, credit card information, screen name, username, password, and e-mail address.

We can be reached via the form provided on the “Contact Us” page of our website.

We collect the e-mail addresses of those who communicate with us via e-mail, information volunteered by the consumer, such as survey information and/or site registrations, name and address, telephone number.

The information we collect is used to improve the content of our Web page, used to notify consumers about updates to our Web site, used by us to contact consumers for marketing purposes.

If you do not want to receive e-mail from us in the future, please let us know by completing our “Contact Us” form.

If you send another person an e-mail from the website referring that person to the website, any “referral” information you provide is used on a one-time basis to facilitate this communication and is not further retained by ActionCOACH.

If you supply us with your postal address on-line you will only receive the information for which you provided us your address. Persons who supply us with their telephone numbers on-line will only receive telephone contact from us with information regarding orders they have placed on-line.

When you voluntarily disclose your Personal Information on a bulletin board or in a chat area, that Personal Information can be collected and used by other users of the website. This may result in unsolicited messages or e-mails from other users or third parties.

With respect to Ad Servers: We do not partner with or have special relationships with any ad server companies.

From time to time, we may use customer information for new, unanticipated uses not previously disclosed in our privacy notice. If our information practices change at some time in the future we will post the policy changes to our Web site to notify you of these changes and we will use for these new purposes only data collected from the time of the policy change forward. If you are concerned about how your information is used, you should check back at our website periodically.

Be advised, that ActionCOACH will release your Personal Information if required to do so by law, search warrant, subpoena, or court order.

Customers may prevent their information from being used for purposes other than those for which it was originally collected by sending a message through the "Contact Us" form.

ActionCOACH takes reasonable precautions to keep Personal Information secure. All Personal Information is subject to restricted access to prevent unauthorized access, modification or misuse.
